2. Academic Audit ~~Committee~~ Committee conducted the Academic Audit of all teaching departments from 13 May 2016 to 30 May 2016. In accordance with NAAC evaluation process each department is audited based on the following Seven Major Criterion.
 - a. Curricular Aspects
 - b. Feedback Schemes
 - c. Teaching Learning Process
 - d. Research Consultancy and Extension
 - e. Effective use of ICT
 - f. Student support and Progression
 - g. Governance and Leadership
3. The sub categories under each criterion is evaluated on a five point scale based on the evidences provided at the time of Academic Audit. The observations of the Academic Audit Committee along with the department performance index is given to the department as a feedback to improve upon.
4. For comparative purpose Relative Performance Index is also calculated. Consolidated academic audit report is presented in the IQAC meeting and IQAC members appreciated the earnest effort of Academic Audit Team.
